Submission deadline: 17th September 2017, 11.59 pm CET (Central European Time)

Winner announcement: 6th October 2017

## Art. 4. Prizes

The winners will be awarded the following prizes

- . Senior cathegory (over 30) 2.000 euros
- . Junior cathegory (under 30) 1.000 euros

For the winners and selected participants

- Exhibition at Centro Culturale Candiani from November 2017 to January 2018 with publication on Gente di Fotografia magazine
- Production of the exhibition curated by Centro Culturale Candiani

In order to be awarded, the winner must guarantee his/her presence at the event.

Any expenses incurred for travel will be sustained by the winner.

#### Art. 5. Competition jury

External jury includes art, communication and photography experts.

The president and the jury list will be announced on the website of the competition.

Jury's final decision shall be considered irreversible

# Art. 6. Registration

Registration is free and shall take place exclusively via email or\_via file sharing (Dropbox, Wetransfer etc). The subscriber will have to send entry form (filled in with their personal data) in digital format word or text file plus scan of the signed entry form and photos by electronic mail at tutticoloridelcinema@comune.venezia.it, or indicate the link from where we can download the photos also highlighting the deadline.

## Art. 7. Participation

- 1. Participation requires up to 10 max. photographs colour or black and white, never awarded in any other national and/or international competition.
- 2. Only digital images are allowed (1080 pixels on the short side) 72 dpi resolution, color or B/W, JPG format.
- 3. File naming must observe the following sequence:
- SURNAME\_INITIAL OF THE NAME\_PROGRESSIVE NUMBER OF THE IMAGE. E.g. Bianchi\_A\_001.jpg (for the first photograph), Bianchi\_A\_002.jpg (for the second photograph), etc.
- 4. A description of the project is required (2500 characters max. with spaces).
- 5. A brief biography of the author/authors is accepted (optional 1500 characters max. with spaces).
- 6. All documents (registration form properly filled and signed, photographs, description of the project and curriculum vitae, if present) can be compressed in a single file (.zip or .rar, no larger than 25MB) named after the project.
- 7. The winners must provide digital high-resolution images within 15th October 2015, scaled to be printed in a 60×80 cm format for the exhibition.

# Art. 8. Author's rights

The author keeps the ownership of rights to visual works. Participation in the contest implies that the author has got the permission to use the images by each person who may be portrayed. The author takes full responsibility for the use of images. The competition sponsors are hereby exonerated from any liability.

## Art. 9. Use of images

The author retains full ownership of the photographs and grants permission to the sponsor to use, reproduce and publish them everywhere without any charge (commercial purposes excluded) and without any temporal limitation – including the sponsor websites, social networks, newsletters, printed material (flyers, posters, catalogues) and on exhibition catalogue whenever realised.

All authors hereby state that no payment will be claimed for possible publication of the photographs on magazines, newspapers, websites and/or social networks.

Centro Culturale Candiani retains full ownership of the printed photographs used for the exhibition. They can be requested by the author or by Gente di Fotografia magazine to set their exhibitions.

## Art. 10. Responsibility

Authors retain full responsibility for the submissed content. The sponsors disclaim their liability with regard to the images uploaded by users and possible copyright infringements.

In any case, entrants commit to indemnify and hold Gente di Fotografia and Centro Culturale Candiani harmless from any claims, requests, responsibilities and, in general, from any rights or claims of third parties regarding and related to the content.

violating any person's privacy or image, reputation of third parties or laws – images considered vulgar, racist, classist or in any case potentially harmful in any way to minors.
